Sir,

Kindly refer to your letter No. JIAR/2021/616 dated 12-05-2021, where under a copy of communication referred to above from the Ministry of AYUSH, Govt. of India, New Delhi, has been forwarded for additional round of counseling for filling up of 30 enhanced seats of BAMS-UG course and 15 seats of PG(MD Ayurveda) courses for academic year 2020-21.

In this connection, it is pertinent to mention here that keeping in view the prevalent COVID-19 situation and as per the guidelines/ SOP's/ lockdown announced by the UT Govt. of J&K, having regard of 7 days' time granted by the concerned Ministry to fill up the enhanced seats of UG BAMS course and seats of AYUSH PG(MD Ayurveda) courses for the academic year 2020 and to explore the possibility as not to allow wastage of seats, the Board has decided to advise you to take necessary steps for filling up of these enhanced seats by the eligible candidates of NEET UG-2020 with the eligibility and cut off score already notified by the Board through various notifications/Notices from time to time .The allotment of seats to the eligible candidates shall be made strictly in order of merit, which includes P&B seats and Management Quota seats also under rules.

Further, the 15 PG seats of three different streams of MD AYUSH courses 2020 may also be filled up on the basis of merit Cum preference basis by the eligible candidates who may have qualified AIAPGET-2020 entrance test with the cut off score prescribed by the Ministry of AYUSH given below:-

OM category	40 <sup>th</sup> Percentile (Cut-off score 135)	
SC/ST/OBC	30 <sup>th</sup> Percentile (Cut-off score 119)	
PWD OM category PWD SC/ST/OBC	35 <sup>th</sup> Percentile (Cut-off score 126) 30 <sup>th</sup> Percentile (Cut-off score 120)	

The whole exercise should be completed in a smooth and transparent manner within the prescribed time limit at your own risk and responsibility and through wide publicity in public domain. The list of provisionally selected/admitted candidates shall be furnished to the Board by last date of admission strictly as per the letter No: F. No.L-14014/239/2020-EP-I dated 12-05-2021 of Ministry of AYUSH, Govt. of India.

However, this is a onetime measure for your College only as per the letter of Ministry of AYUSH, Government of India, and should not be treated as a precedent.
